SIGNAGE

SECTION 11 STREET SIGNS

- Section 11.1 <u>All New Street Signs</u> erected on private streets within Gilmer County shall be in conformance with the specifications of this section. A typical street sign installation will designate one street using one nameplate, double sided.
- Section 11.2 The Owner of any Subdivision or other development where a street sign is required shall erect or cause to be erected a street sign using this specification in this Section. To ensure uniformity, street signs throughout Gilmer County, shall be in conformance to the type, size, style, color, material, placement, and any other specifications mandated by the Gilmer County Commission or its representatives. The owner of any subdivision, any property, or any other development where a street sign is required shall provide funding. The Lewis-Gilmer Addressing Office will initiate the installation of the street sign(s). Any signs not in conformance to the specifications of this ordinance shall be removed and signs that are in conformance shall be erected, all at the expense of the owner or party responsible for the subdivision, property, or other development.
- Section 11.3 The Third Addressable Structure built on a right-of-way not otherwise named may cause the right-of-way to be named. The addressing office shall coordinate and oversee the naming of the right-of-way. The Addressing Office shall provide road name petitions to all owners of residences affected by the road name change and shall provide a specific timeframe for a response. Through a majority vote and within the stipulated timeframe per the petition, the owners of residences affected by the road name change shall agree upon a road name and submit the road name for approval. If agreement of the road names does not occur, the Gilmer County Commission shall have the authority to name the road.

- (Section 11.3 cont'd) The Lewis-Gilmer E-911 Center shall be responsible for any and all fees to manufacture and install any and all signs on the newly named private road. The Lewis-Gilmer Addressing Office will initiate the installation of the street sign(s). All signs shall conform to the specifications of the Ordinance.
- Section 11.4 <u>Except as approved</u> by the Gilmer County Commission, no other sign of any type shall be attached, permanently or temporarily, to any road name signpost. At no time shall a stop sign be mounted to a road name signpost. All stop signs on developments, private/subdivision roadways shall be individually mounted to its own post.
- Section 11.5

 Sign Specifications State Maintained Roadway All signs adopted by the West Virginia Department of Transportation, Division of Highways shall be in conformance at minimum to the West Virginia Department of Transportation, Division of Highways as defined in the "Standards for the Design and Installation of Road Name Signing" published March 1999

 The State of West Virginia shall have the final authority as to the type and size of sign erected on their right-of-way.
- Section 11.6 <u>Sign Specifications Private Roadways</u> For signs placed in conformance to the ordinance, all nameplates shall use aluminum sign blanks of .080 thickness, degreased and etched, ready to accept pressure sensitive materials. Corners shall be radius prior to application of the reflective sheeting. The sheeting shall be a brand of Engineering Grade High Intensity, not prism Reflective Material.

The sign size for a roadway shall be six (6") inches high x 18", 24", 30", or 36" in length.

The sign color (reflective sheeting) shall consist of white lettering and border on a green background for any roadway

Section 11.6 cont'd.) The letter size and type shall conform to the "Standard Alphabets for Highway Signs", uppercase. Should the road name still not fit on the longest sign length, the text height shall be reduced by ½" increments until the road name fits. Abbreviations may be used as suitable alternatives however the addressing office shall have final inspection and approval on signs that require a reduced letter size or abbreviation. The normal spacing between words shall be the width of the letter "H" in the same series and height used in the street name.

For a roadway, the standard text height of the road name shall be three (3") inches uppercase for all private roads as well as for those roads intersecting those roads The standard text height of the prefix and suffix shall be three (3") inches uppercase.

- Section 11.7 <u>Sign Specifications Private/Subdivision/Developments</u> All signs erected shall be in conformance to the above standard. If the owners decide to do something different than the specifications, the owners must write a letter to the Gilmer County Commission requesting a meeting with them and the addressing office for a decision. The Gilmer County Commission shall have final authority for the size, style, and color of the sign to be erected if not in compliance with above.
- Section 11.8 <u>Sign Post Specifications</u> For developments/private/subdivision roadways, the nameplate signpost shall consist of an upper signpost and a lower base post or anchor. The signpost shall meet WVDOH specifications. The base post shall be a thirty-six (36") inch, anchor, driven into the earth to a depth of at least thirty-two (32") inches. The base post shall not extend more than four (4") inches above grade. Anything different than previous mentioned, must be approved by the Gilmer County Commission, as stated in the previous subsection.

Lateral clearance of 6ft. – 12ft. from edge of pavement.

Vertical clearance of 7ft. from edge of pavement to bottom of the sign should be maintained.

- Section 11.9 <u>Sign Mounting</u> The street name signs shall be fastened utilizing a mount that bolts to the posts and the sign be attached with set screws.
- Section 11.10 <u>Sign Post Installation</u> On all roadways, all street name signs shall be located on diagonally opposite corners and mounted with their faces parallel to the streets they identify. Only the sufficient amount of street name signs is needed to properly identify the roadway. The addressing office shall have the authority to identify and cause installation of the proper amount of signs at a given intersection as deemed necessary.

The Lewis-Gilmer Addressing Office shall mark all locations where a street sign is to be placed. A white X shall be used with a white flag in the center showing the exact spot. The road name shall be written on the flag.

The Miss Utility locating service shall be notified by the installer to see if any Utilities are in/or around where a street name sign is placed, and marked accordingly

For a roadway identified as a "dead end" roadway not having any other intersection with any other road, only the name of the "dead end" roadway shall have a sign installed, commonly referred to as a one-way sign.

Street name signs shall be located to assist the motorist and Emergency Response Agencies in locating the street name while not blocking the view of motorists exiting onto the street from which they are traveling.

Section 11.11

Signage Which Is Damaged or destroyed shall be the responsibility of the individual(s) causing such damage or destruction, whether by negligence or otherwise. The agency or individual(s) responsible for maintenance of the damaged sign shall have the authority to recover the costs of replacing the sign from the individual(s) causing such damage or destruction.

Section 11.12	Any Such Person Found to be responsible for damage or Destruction of any road or street sign shall pay to the County

The purpose of this ordinance is to allow the Gilmer County Commission to have initial street signs installed on private streets in Gilmer County. This does not include signs for municipalities. All signs will be 6 in. green and white reflective, using uppercase 3in. lettering. This will differentiate between private streets and state roads.
